What is the Award Closeout Report?

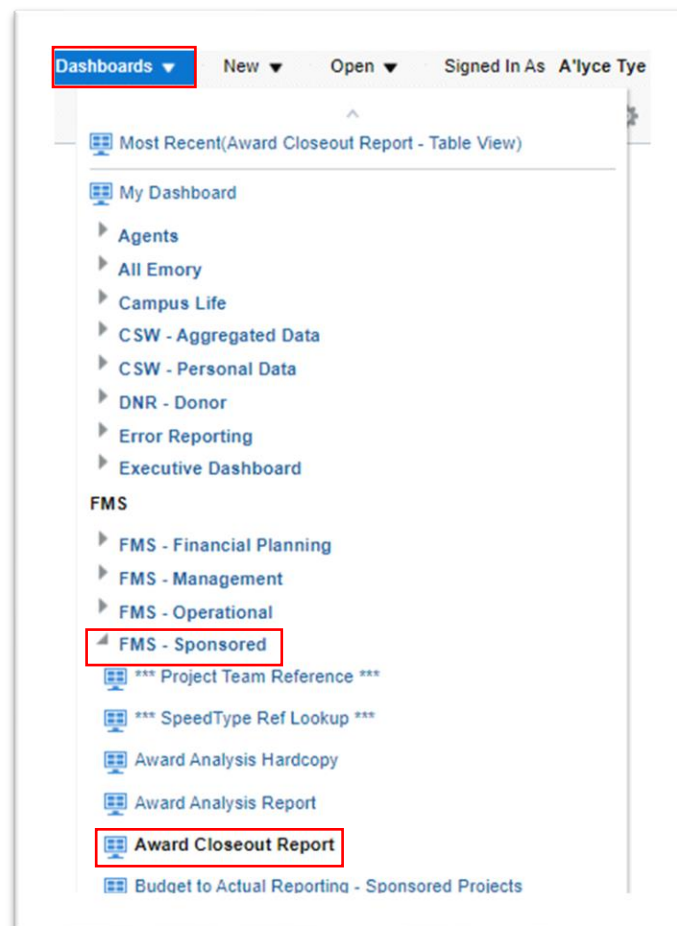
The Award Closeout Report displays details about awards based on their end date. The dashboard consists of two reports, the Summary, and the Table View.

When should I use the Award Closeout Report?

This report is useful when you are looking for awards with negative [cash balances](#) that have ended or will end during the time period prompted. The Summary view can be used to see Counts and [Cash Balances](#) by category and the Table view displays specific details for each award.

Where do I find this report in EBI?

1. Log in to EBI: <https://dwbi.emory.edu/analytics>
2. Click on the Dashboards Menu in the upper right corner
3. In the FMS – Sponsored folder, click the Award Closeout Report link.

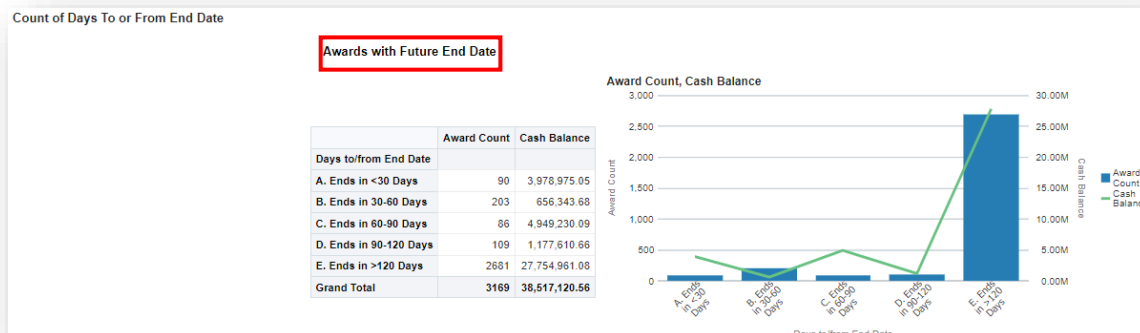

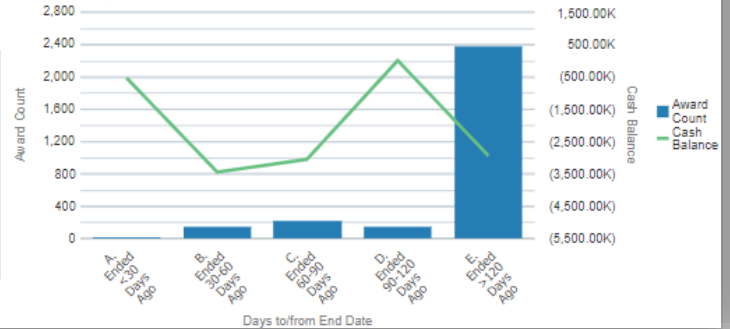

Column Definitions

- Award ID** - The unique identifier assigned to an Award.
- Principal Investigator** - The lead researcher for a particular well-defined project (grant), often in the sciences, such as a laboratory study or a clinical trial.
- Award End Date** - Date marking the end of the valid award period.
- Award End Fiscal Year** - The fiscal year in which an award ends.
- Award Department** - The home department of the PI on the award.
- RAS Unit** - The specific unit assigned to manage the lifecycle of the award.
- Sponsor Name** - The descriptive name of the external entity from whom the funds are obtained. A sponsor may be a corporation, foundation, or government agency.
- Sponsor Type** - The type of entity or institution that sponsors the award.
- Contract Type** - Describes the type of contract that identifies how Emory will expect to collect the dollars associated with an award or contract.
- Project Type** - Describes whether a project is part of an award that has been funded by a Federal or Non-Federal entity (sponsor).
- Award Status** - Indicates Emory's processing status of the award. Valid values include: Accepted, Closed, Refused, and Withdrawn.
- Contract Status** - Indicates Emory's processing status of the contract. Valid values include: Active, Closed, Ended and Pending.
- Budget** - Total dollar amount approved by the sponsor, based on total expenses proposed by the PI for a particular award. These dollars must be applied to expenses which fall within the proposed and approved work and must be expended prior to the award end date.
- Encumbrance** - Open commitments to a transaction that are not considered actual expenses but should be considered for budget planning.



- 15. Expenses** - Expenses are outflows or other uses of assets or incurrence of liabilities from delivering or producing goods, rendering services, or carrying out other activities which constitute the institution's major operations.
- 16. Budget Variance** - This is a comparison of expenses versus the budget and the amount over or under budget.
- 17. Cash Balance** - Account 11000, claim on cash (current balance of expenses less payments received).
- 18. Cash Balance Category** - Cash balance threshold amount used for consideration to determine if a write-off is appropriate to close the award.
- 19. 11330-RPPF** - Amount reflected on account code 11330 for Research Participant Payment Funds on Sponsored Projects.
- 20. 14650-AR SP** - Open accounts receivable (expenses have been billed to the sponsor and payment is still outstanding).
- 21. 14660-AR UB SP** - Current expenses available to be billed to the sponsor.
- 22. Other Asset Accounts** - Asset accounts other than 11000, 11330, 14650 and 14660.
- 23. 25700 Deferred Revenue** - Represents payments received in advance for good/services to be delivered in the future.
- 24. Other Liab Accounts** - All account codes beginning with 2 excluding 25700, Deferred Revenue.
- 25. # of Days Since End Date** - The number of days that have passed since an award has ended.
